SUBJECT: Report on 2020/21 Commission Activities

*This is an Informational Report. No Action is Necessary*

### DISCUSSION

The first Commission meeting of the year is an appropriate time to review the Commission's activities during the past year and planned activities for the upcoming year.

Staff will prepare a power point presentation for the January 14, 2021 meeting to highlight the Commission's accomplishments in 2020 and expected activities in 2021.

**Transitions.** Change in life happens and SBLAFCO's lost great leadership with the passing of Paul Hood. Paul had led LAFCO for the last seven years and was well respected around the State. Legal Counsel William Dillion was appointed as Interim during the last seven months. Mr. Dillion continued the high level of service during his tenure. I am honored to follow Bill and Paul as SBLAFCO's Executive Officer.

Bill Dillion continues as our steadfast legal counsel and advocate over the years. Bill and my public agency experience and commitment to service will optimistically kept LAFCO on track and moving in the right direction.

With COVID-19 in Santa Barbara County and throughout the State we all have high hopes of seeing a decreasing trend. Our hopes for good news along with our collective efforts to slow and ultimately stop the spread for 2021 are on order.

**Commission Pulls Together.** LAFCo's were created to manage change. In the last year the Commission has done such a good job of facilitating change. We have tackled challenging issues with a respectful and listening attitude towards the public, applicants and each other. This creates a very good decision making environment for all parties. Special thanks to this year's LAFCO Chair, Craig Geyer, for running an efficient and respectful ship. High praise for the Commission for giving your patient and thoughtful effort to the issues we work on for the County, Cities and Special Districts. Let's make 2021 another great year.

## **SUMMARY OF 2020**

In 2020 Santa Barbara LAFCO completed the analysis and processing of a number of proposals, LAFCO Staff provided information and assistance to the public, agencies, developers, and others involved in LAFCO activities. The Commission considered a number of status and informational reports. The Commission participated in the CALAFCO legislative activities and program activities. The Commission also appointed a new Executive Officer.

### **PROPOSALS AND POLICIES (CKH 56069)**

A proposal is defined in the CKH Act as "a change of organization or reorganization initiated by petition or resolution of application by a legislative body or school district for which a certificate of filing has been issued." Commissioner Handbook set the foundation for decision making and is periodically reviewed. The following have been reviewed, approved or completed by LAFCO over the last year:

**Formation of the San Antonio Basin Water District.** In May, LAFCO completed the filing of the Commission's approval of the San Antonio Basin Water District from July 11, 2019. The protest hearing was on August 30, 2019, the district formation was set for a mailed ballot election held on April 7, 2020. On April 15, 2020, County Clerk Recorder-Assessor, certified the canvass of the returns of votes cast and determined the value of the votes as follows: 66,366 in favor and 400 against The Board of Supervisors declared the results of the election on April 21, 2020.

**Sienna Way Annexation to the Santa Ynez Community Services District.** The 3 approximately 1-acre property were annexed into the Santa Ynez Community Services District primarily for wastewater services. The area is within the Janin Acres Special Problems Area.

**Sunrise Hill Lane Out of Agency Services Agreement and City of Santa Barbara Sphere of Influence Amendment.** This property was in need of water and sewer services and the

City had water and sewer mains in the area with capacity sufficient to service the property. An OSA was approved on September 3, 2020.

**Los Olivos Community Services District Formation Compliance.** The Los Olivos Community Services District was granted a time extension to implement a Proposition 218 assessment to fund planning and construction work necessary to build a wastewater treatment system as required by Commission Resolution 17-04.

**Montecito Sanitary District Sphere of Influence Amendment and Judith Little Property Annexation.** The Commission approved a 5.68-acre property with an existing residence to be annexed into the District.

### **SPHERE OF INFLUENCE-MUNICIPAL SERVICE REVIEW UPDATES**

**Report on Isla Vista MSR Update.** Receive a report on the Municipal Service Review to be scheduled for the Isla Vista Community Services District and give direction to Staff regarding communications with the District regarding legal authority, next steps and schedule for the proposed MSR. The Commission directed Staff to start a Municipal Service Review for the Isla Vista Community Services District by June 2023.

**MSR Update.** A status report of Municipal Service Reviews and Sphere of Influence Amendments were given. The Commission will need to consider the workload schedule for conducting these service reviews.

### **OTHER KEY ACTIVITIES**

**Report regarding City and Special District Selection Process.** The City Selection Committee, comprised of the mayors or their designees, makes the City member appointments to the Commission. City Council members meet on a regular basis because they also serve on the Santa Barbara Council of Governments (SBCAG), and the Santa Barbara County Air Pollution Control District (APCD). Special Districts, assembling a quorum (20 members) of the special districts for a meeting of the Special District Selection Committee, or LAFCO runs a mailed ballot election.

**Election Appointments.** A mailed -ballot election was conducted and both Regular Commissioner Geyer and Alternate Special District Allen were re-elected. Regular City member Roger Aceves and Alternate City Member Holly Sierra's were reappointed.

**UCLA Planning and Land Use Conference.** Annual program, included practitioners from

both land use law and planning disciplines providing balanced analysis of critical legal cases that affect land use decisions.

**Staffing Options/EO Recruitment.** Appointed LAFCO legal counsel William Dillon as interim Executive Officer, established an Ad Hoc Committee on recruitment, held meeting with the interim Executive Office and briefed the Commission on efforts.

**Monitored State legislation** and informed the Commission of the various pieces of legislation that might affect LAFCO.

**Fiscal/Budget.** Received and filed Financial Statements for FY ending June 30, 2019. Considered and approved the Fiscal Year 2020-21 LAFCO Budget and regular disbursement/Quarterly Budget Status Reports. Each transaction from the LAFCO budget is paid by processing a draw warrant or journal entry through the County's financial tracking system.

**CALAFCO** is the statewide organization of LAFCOs and is dedicated to meeting the continuing educational needs of LAFCO staff and tracking legislative activity in Sacramento. Regular updates, as needed, are given to inform the Commission on related matters.

## WORK PLAN - JANUARY 2021

---

This document is the Work Plan for Santa Barbara LAFCO in 2021. LAFCO's overarching legislative goals include the following:

- **Encourage Orderly Growth and Development.** LAFCO considers proposals for the formation of new local governmental agencies including Cities and Special Districts. LAFCO is also responsible for considering annexations and detachments for agencies. LAFCO also determines the Sphere of Influence, which is a plan for the probable physical boundary of a City or Special District.
- **Promoting Efficient Provision of Public Services.** LAFCO reviews proposals based on a variety of factors including: a plan for services submitted by the agency, resource and infrastructure capacity, and the need for services.
- **Preserve Agricultural Land Resources.** LAFCO considers the impact that a proposal may have on existing agricultural lands with focus on prime agricultural lands. Santa Barbara LAFCO has adopted specific policies regarding the preservation of agricultural resources.
- **Discourage Urban Sprawl.** Urban sprawl can best be described as irregular and disorganized growth occurring without apparent design or plan. By discouraging sprawl, LAFCO limits the misuse of land resources and promotes a more efficient system of services by local governmental agencies.

### **Goals in 2021**

1. Serve the Commission and the public by providing accurate, clear and well-organized information for decision making.
2. Treat the public, applicants, Commissioners, and any stakeholders with respect and patience. Listening with consideration and responding in a calm, courteous manner.
3. Serve the Cities, County and Special Districts by providing information about LAFCO's purpose and the processes LAFCO is authorized to complete.
4. Process proposals in an efficient manner; consistent with the Cortese-Knox-Hertzberg Act, CEQA and other state laws.
5. Implement the Sphere of Influence/Municipal Service Review Update Work Plan, while working on applications and other topics at the same time.
6. Provide the Commission with regular status reports regarding upcoming proposals, Sphere of Influence Updates, Legislative Activities, and the Budget.

7. Participate in CALAFCO events to improve the Commission and Staff's expertise.
8. Inform the Commission and Public regarding various local governance issues and processes by providing regular status reports and study sessions.
9. Monitor the new legislation in the State legislature that may affect LAFCO.

## **RADAR: ANNEXATIONS – DETACHMENTS – OTHER ACTIONS**

Several Cities and Districts may have annexation or detachment proposals on the horizon. A Memoranda of Agreement between the Cities and County could help set the path for these annexations or future ones by providing the provisions for development of an area. Annexation Proposals that may be on the horizon include:

- 1075 San Antonio Creek Rd, Brown Annexation, Goleta Sanitary District
- 691 N. Hope Avenue Reorganization, City of Santa Barbara

Most of these proposals have been submitted, it is uncertain if all proposals will be submitted this year or within the next fiscal year, but planning and environmental work is being completed on each of these proposals. LAFCO Staff continues to monitor each project and provide comments at the appropriate times.

## **SPHERE OF INFLUENCE/MUNICIPAL SERVICE REVIEW UPDATE**

Sphere of Influence & Municipal Service Reviews. The current statute requires LAFCO to update the Spheres of Influence for each jurisdiction every five years. The Sphere of Influence is based on a service review. An outline of the review is provided below. The Commission could consider adopting a work plan that updated the MSR's on a regular



basis that considers either each agency independently or combine agencies by regions/sub region, resources services, or some other approach. An Ad Hoc Committee could be appointed by the Chair that looks at the various approaches statewide and report back to the full Commission. The Commission could then direct the Executive Officer to develop a MSR Program that achieves the five-year update.

The Sphere of Influence is a boundary that identifies areas a jurisdiction might serve over the next 20 years. The Municipal Service Review provides information about a jurisdiction's ability to serve its existing service area and other SOI areas. The MSR is an informational document that summarizes the existing service situation of a jurisdiction. The Service Review compiles information provided by the jurisdiction.

Other information from the County Planning and Development Department, State Controller's Office, County Auditor's Office, and other agencies is also used to prepare the SOI and MSR. LAFCO Staff reviews, summarizes and evaluates the various studies and data and prepares a Draft Sphere of Influence Update and Municipal Service Review.

A Municipal Service Review is prepared in accordance with Section 56430 of the California Government Code. This code section was updated in 2012 to include seven factors instead of the previous six factors. The Service Review contains information and written determinations regarding each of the factors provided in the Service Review which include:

1. Growth and Population projections for the affected area.
2. Location and characteristics of any disadvantaged unincorporated communities
3. Present and planned capacity of public facilities and adequacy of public services, including infrastructure needs or deficiencies
4. Financial ability of agencies to provide services
5. Status of, and opportunity for, shared facilities
6. Accountability for community service needs including governmental structure and operational efficiencies
7. Any other matter related to effective or efficient service delivery, as required by commission policy

Also, administrative and organizational information is collected and evaluated. In order to complete a review LAFCO relies on Audit Reports submitted to the LAFCO and County Auditor Controller's Office pursuant to state law, original formation filing documents, State Controllers Special Districts Annual Financial Reports, the General Plan, Capital Improvement Plans, various studies and information from various websites.

## CITIES

The 2021 Work Plan could focus on those Cities which have passed, or are approaching the five-year requirement for an SOI update. In 2016 Staff updated the spheres of influence for many of the Cities. Work could begin on the City of Goleta, which is the oldest SOI outstanding. Typically, annexations or other proposals could temporarily delay these updates while applications are being processed to meet statutory deadlines. Below are the Cities and the five-year update schedule:

**Memorandum of Agreement (MOA).** A MOA should be developed to improve communication and coordination in planning for future growth and development between a Cities and the County. Currently, no City has an MOA with the County. A draft MOA is underway with the City of Lompoc. The Memorandum of Agreement between the City and County would be reviewed and amended to reflect any changes to the Sphere of Influence and provisions that are agreed to by the County and City.

An MOA can provide more detail about what type of development might be expected in the SOI and assist in defining the boundary. This helps clarify expectations and provides guidelines that help guide future projects in the SOI. The MOA can also be used to specify a particular planning process or policies for specific areas. Also, the MOA should address other issues such as water resources and agricultural/open space preservation. A comprehensive SOI/MSR Program should focus on areas of communication and coordination between the Cities and County.

## SPECIAL DISTRICTS

The 2021 Work Plan could focus on those Districts which have passed, or are approaching, the five-year requirement for update. Staff recommends that the schedule for updating the SOIs and MSRs for the Districts be followed as shown in the table below, unless an alternative approach is selected.

## COMMUNITY SERVICES DISTRICTS

There are numerous Community Services Districts that are providing a variety of services to County residents. These Districts found below provide services that have been activated by LAFCO including: water and wastewater, fire protection, street lighting, roads, storm water, transportation and solid waste. Each of these Districts is subject to the principal act in the Government Code 61000 – 61250 and has an independent Board of Directors.

## **MAPPING PROGRAM**

The Santa Barbara County Surveyor staff prepares the maps that are an essential part of all reports. The Surveyor's office continues to implement and improve LAFCO's Geographic Information Systems (GIS) mapping program. This program produces a number of important deliverables including the updated Service Areas and Spheres of Influence for all Cities, Special Districts, and County Service Areas in the County. LAFCO is responsible for helping to maintain the boundaries for jurisdictions throughout the County. The County Surveyor office provides a history of annexations online through an inventory of all annexations and sphere amendments. This inventory includes a general directory, basic information, and summary maps. Maps are created for each annexation and sphere of influence update considered by LAFCO. Mapping is a key piece of LAFCO's service capability.

## **CALAFCO ACTIVITIES**

CALAFCO is LAFCO's statewide organization that provides educational opportunities, follows and facilitates the discussion of issues on a statewide basis. The LAFCO EO serves CALAFCO by providing help as needed and requested. Staff and Commissioners have been involved in the continuing education process by participating in the annual CALAFCO Conference and attending the Staff Workshop. CALAFCO also offers virtual education opportunities with AICP and MCLE credits viewable on their website.
