- The 2016 CALAFCO Annual Conference was held at the Fess Parker Doubletree Hotel on October 26-28, 2016
- The theme for the conference, "Orchards to Oceans: Balancing California's Diversity," set the stage for the three-day event. The Conference was a great success and many accolades were received from attendees.
