September 1, 2005

Board of Supervisors Hearing Room Santa Barbara CA

- 1. Chair Tim Campbell called the meeting to order at 2:05 p.m.
- 2. Present were Commissioners Campbell, Centeno, DeWees, Fox, Orach, Rose and Stableford, Alternate Commissioners Firestone, Hawxhurst and Schlottmann, Executive Officer Bob Braitman and Legal Counsel Alan Seltzer. Commissioner Leich participated by remote connection from Santa Maria.
- 3. The Pledge of Allegiance was recited.
- 4. Upon motion by Centeno, second by Orach, the minutes of the August 4, 2005 meeting were approved as submitted.
- 5. Public Comment Period There were no comments from the public.
- 6. Expand the sphere of influence of the City of Solvang and 05-14 Out of Agency Service Agreement City of Solvang (Seltzer)

After due consideration, upon motion by Orach, second by Centeno, the Commission found the proposal to be Categorically Exempt, amended the City sphere of influence and authorized the City to provide sewer service as recommended.

7. 05-11 – Hudgens Reorganization: Annexation to the City of Lompoc/Detachment from the Santa Barbara County Fire Protection District/Detachment from the Santa Barbara Coastal Vector Control District

Lucille Breese spoke representing the City of Lompoc.

After due consideration, upon motion by Orach, second by Stableford, the Commission found the proposal to be Categorically Exempt, approved the proposal and waived conducting authority proceedings.

8. Expand the sphere of influence of the Goleta Sanitary District and 05-13 – San Marcos Gardens Annexation to the Goleta Sanitary District

After due consideration, upon motion by Rose, second by Fox, the Commission amended the sphere of influence of the Goleta Sanitary District, found the proposal to be Categorically Exempt, approved the proposal and authorized the staff to proceed.

9. Municipal Service Reviews and Sphere of Influence Updates for local agencies in the Santa Barbara/Goleta Valley area

The Executive Officer presented an introduction to Municipal Service Reviews in the Santa Barbara/Goleta Valley area.

The Commission considered each local agency individually and took the following actions.

A. County Service Area No. 3 (Goleta Valley)

After due consideration, upon motion by Rose, second by Orach, the Commission approved the Municipal Service Review determinations as recommended and adopted the resolution updating the Sphere of Influence.

B. County Service Area No. 31 (Isla Vista)

After due consideration, upon motion by Orach, second by Rose, the Commission approved the Municipal Service Review determinations as recommended and adopted the resolution updating the Sphere of Influence.

C. County Service Area No. 32 (Law Enforcement)

After due consideration, upon motion by Orach, second by Stableford, the Commission approved the Municipal Service Review determinations as recommended and adopted the resolution updating the Sphere of Influence.

D. Embarcadero Municipal Improvement District

After due consideration, upon motion by Orach, second by Fox, the Commission approved the Municipal Service Review determinations as recommended and adopted the resolution updating the Sphere of Influence.

E. Goleta Sanitary District

The staff presented a supplemental report recommending the current of sphere of influence be affirmed and staff be directed to monitor the prospective consolidation of the Goleta and Goleta West Sanitary Districts.

Kamil Azoury spoke representing the Goleta Sanitary District.

After due consideration, upon motion by Orach, second by Rose, the Commission approved the Municipal Service Review determinations as recommended and adopted the Sphere of Influence as recommended in the supplemental staff report.

F. Goleta West Sanitary District

After due consideration, upon motion by Orach, second by Rose, the Commission approved the Municipal Service Review determinations as recommended and adopted the Sphere of Influence as recommended in the supplemental staff report.

G. Goleta Water District

Kevin Walsh spoke representing the Goleta Water District.

After due consideration, upon motion by Orach, second by Rose, the Commission approved the Municipal Service Review determinations as recommended and adopted the resolution updating the Sphere of Influence.

The staff was directed to schedule an item on a Commission's future agenda regarding the "overlap" between the District and the City of Santa Barbara water service areas.

After due consideration, upon motion by Orach, second by Stableford, the Commission approved the Municipal Service Review determinations as recommended and adopted the resolution updating the Sphere of Influence.

J. Santa Barbara County Fire Protection District

After due consideration, upon motion by Orach, second by Rose, the Commission approved the Municipal Service Review determinations as recommended and adopted the resolution updating the Sphere of Influence.

K. Santa Barbara Metropolitan Transit District

10. Appointment of voting member and alternate for the CALAFCO Conference

Upon motion by Centeno, second by DeWees, Commissioner Orach was appointed as voting delegate and the Executive Officer as alternate voting delegate at the CALAFCO Annual Conference.

- 11. Ratify Disbursements This item was continued to the next Commission meeting.
- 12. Discussion of LAFCO meeting schedule for the remainder of 2005

Due to a conflict with the annual meeting of the League of California Cities the Commission canceled the regular October 5 meeting and authorized the Chair and Executive Officer to schedule a special meeting on October 26 if necessary.
