# SPHERE OF INFLUENCE ITEM No. 1 - City of Lompoc Proposal to Expand the Sphere of Influence for the Bailey Avenue Properties – REQUEST FOR CONTINUANCE

Dear Members of the Commission

#### RECOMMENDATION

It is recommended that the Commission hear the full staff report and presentation on December 8 and continue this matter to Februrary 2, 2023 for submission of additional information and deliberation on the merits.

#### DISCUSSION

The Environmental Defense Center and members of the Public have requested that this matter be continued. Staff recommends the Commission should be briefed December 8 on the material and ask any questions, as necessary, and continue the hearing for deliberations on the merits. The Commission is asked to not deliberate on the merits on December 8. The next available hearing date in Santa Maria is February 2, 2023.

The staff report and supporting material is lengthy and more time would benefit the Commission and public with greater time to review the information concerning this important decision. It is recommended staff give our full report and presentation on December 8 before the hearing is continued. At the December 8 hearing it is further recommended the Commission:

- 1. Hear the staff report and presentation by Executive Officer.
- 2. Ask any clarifying questions and hear responses from staff or counsel, as appropriate.
- 3. Open Public Comment Period. Members of the public are requested to limit their comments on December 8. The Commission will re-open the public comment

period on February 2, 2023 to hear the main public comments. Any persons who cannot attend and testify at the February meeting should provide their comments at the December 8 hearing.

- 4. Hear Staff or counsel responses to public comment, as appropriate.
- 5. Continue the hearing to February 2, 2023. Staff will report as directed on questions. At the February hearing, the City will have up to 20 minutes to present its application and address questions, followed by members of the public for up to 3 minutes each, then Commission delibertions and decision on the merits. If necessary, the meeting will be continued to March for CEQA determinations and findings.

The City has agreed to continuance and, therefore, does not plan on making its full presentation of its application on December 8.
