Consider Selection of Commission Public Member and Alternate Public Member for appointment to four-year term beginning March 1, 2021

Dear Members of the Commission

RECOMMENDATION

It is recommended that the Commission provide direction to staff.

DISCUSSION

Both the regular and alternate public members' terms are up on 3/1/21. Both have served a 4-year term. The Commissioner Handbook states "It is the intent that an individual not hold two consecutive four-year terms as the Public Member or as the Alternate Public Member. It is recognized that an individual may serve the remainder of an unexpired term of office as the Public Member or the Alternate Public Member before serving a full four-year term in that position."

Both regular and alternate members have request reappointment to their respective positions. (Exhibit A & B).

Government Code Section 56325 requires that selection of the public member and alternate public member be supported by at least one of the members in each of the other categories, i.e., City, County and Special District members.

The Commission could reappoint both members, or direct staff to prepare a recruitment notice pursuant to Government Code Section 56325(d) announcing a vacancy for the Alternate Public Member. Commissioner Hanbook also states "It is the intent that an individual after serving as the Alternate Public Member be appointed to the position of Public Member. Coincident with that appointment, a new Alternate Public Member shall be selected and appointed."

The Commission could appoint a Public Member Selection Committee comprised of three members to review and evaluate any letters of interest. A pending vacancy notice would be sent to the cities, county, special districts, and posted on the Commission's website and an ad placed in the local paper. The recruitment period would run for at least 30-days and may be extended pending level of interest. The Committee would report to the Commission and make a recommendation at a later date and each candidate would be invited for interviews. The Commission, in open session would consider the recommendation of the Selection Committee and appoint the Alternate Public Member.
