Dear Mr. Dillon:

Despite having asked to be kept *promptly* informed of all communications regarding the effort to continue to run SRHCSD, we were not provided until January 15, 2015 with the letter of Mr. Seitz, received by you on January 8, 2015, a week earlier.

The letter was apparently in response to an email you sent him on December 15, 2014 (a copy of which email we were just provided Wednesday last, but only after we were forced to demand it under CPRA), regarding my letter in December objecting to the “ad hoc finance and operations committee” created by the “Board” of SRHCSD to continue that entity’s operations and expenditures without the required Board of Directors.

Even a cursory reading of the Seitz letter, and the limited and usually out of context (or completely irrelevant) citations therein, demonstrates that there is not now, and never has been any possible legal authority for the creation of such an “ad hoc” operations committee, and that its operation violates established state law requirements for non-delegable, elected official auditing and approval of CSD expenditures. I have already cited the legal requirements for payments, and the restrictions on the power of ad hoc committees. Given the lack of authority to the contrary, I will not repeat my citations, but incorporate them herein by this reference.

Further, we have confirmed with Mr. Geis that, despite what Mr. Hood told SBLAFCO on December 4, 2014, SRHCSD was never “working with” the auditor-controller on the concept of an “ad hoc” replacement for the Board, and, according to Mr. Geis, at most there was some brief and vague discussion in a hallway between Mr. Geis and Gary Keefe that Mr. Keefe parlayed into the “plan” he hatched with Messrs. Seitz, Petersen and Freeman to evade California law and the inevitable demise of the SRHCSD, in part so Mr. Keefe could continue to pay himself and so that Wallace Group, the District

“assistant” and the cadre of lawyers hired to condemn my client’s property through creation of yet another “district,” all could use the taxpayer dollars that were supposed to be used to improve repair and maintain roads inside SRHCSD to pay themselves to assist a limited number of land owners in their effort to retain the tax dollars held by the defunct CSD so they can be transferred, as you told then they could, to the proposed “Bridge & Highway District.

The fact that less than one third of the parcel owners – removing multiples for a single parcel - have bothered to sign the “petition” for this new district, despite it having been secretly planned for over a year, and openly circulated for almost four months, should signal to you and Mr. Hood that Messrs. Blanco and Salvucci simply do not have the support of the “vast majority” of landowners they claim to have.

It is important to acknowledge that Mr. Seitz never once denies our assertion that none of those who claimed to be the duly elected “board” of SRHCSD actually were legally allowed to so serve. Instead, as Mr. Seitz so often does, he simply claims that my clients should have spent their money on a lawsuit to prove that which was so obvious, and to do that which the Elections office is charged with doing; exposing voter and/or candidate fraud. We have in fact complained to the elections office. For reasons unclear, Mr. Holland refuses to address the issue. However, we are not finished with that process. Of course, Mr. Seitz ignores that there is no civil law remedy for voter fraud or election fraud; those are criminal matters.

Just to be clear that Messrs. Casey Marks, Tom Freeman and Dale Petersen never have been residents within SRHCSD, we repeat herein the applicable law. SRHCSD is a “Registered Voter District.” A Registered Voter District means a district whose principal act provides that registered voters residing within the district are entitled to vote for the election of district officers, incurring of bonded indebtedness, or any other district matter. (Government Code §56072.) “Registered voter” means any elector registered under, and pursuant to, the Elections Code. (Gov. Code §56071.) While it is true that each of these persons “registered” to vote within SRHCSD, none of them was legally permitted to do so, and their registrations were fraudulent for a number of reasons.

First of all, by BOS resolution in 1986, the entire SRHCSD area is a “special problems” area, and no residences other than the three already located there are permitted (one of which is unoccupied, one of which is only occasionally occupied, and one of which belongs to one of my clients and is continually occupied.) Second, Elections Code 349 provides at subpart (a) “Residence for voting purposes means a person’s domicile.” Subpart (b) of that Section provides that “The domicile of a person is that place in which his or her habitation is fixed, wherein the person has the intention of remaining, and to which, whenever he or she is absent, the person has the intention of returning. At a given time, a person may have only one domicile.”

Public records disclose that Messrs. Marks, Freeman and Petersen all have fixed habitation in other cities, and represent that they do so to others (in Dr. Freeman's case, to the Medical Board of California.) Being sent herewith are the public records searches on Messrs. Freeman (who no longer resides within the District and has sold his property – negating his signature on any new "petition") and Petersen. Mr. Marks, who might actually have had a claim to reside within SRHCSD because his family (but not he) owns an unoccupied house within the boundaries, actually lives on Por La Mar Circle in Santa Barbara and returns there every day after work, and after every trip away from that address. We have not included Mr. Moreno's public information because, once confronted with the facts and law demonstrating the illegality of his being on the Board, he wisely and voluntarily refused to further serve on the Board (and, notably, has not signed any "petition" for a new governmental entity to be formed for his alleged "benefit.")

Thus, there is a clear reason Mr. Seitz cannot claim that any of those who conspired to evade the laws actually were authorized to act for SRHCSD; they were illegally registered and elected, and he knows it.

One of the most glaring, and easily disproved of Mr. Seitz's claims is that "There is one remaining member of the Board, that being Dale Petersen." This is a patently and easily disproved false "fact" regurgitated last week by Mr. Hood in the EO's report for next week's SBLAFCO meeting. Mr. Seitz predicates his entire defense of the "ad hoc" committee on the premise that it has at least one elected board member, as if that was sufficient to ignore all other legal requirements (such as that there must be a "Board" and that for the "board" to act there must be a quorum.)

Mr. Seitz, as he so often does, is simply making up the claim that Dale Petersen is still a Board member (even if he did "reside" within SRHCSD). Mr. Hood, as so often he does, is simply repeating this falsehood to SBLAFCO as if it was fact, as he has done with so many false claims fed to him by those working against my clients (such as that they were "working" with the auditor-controller when they were not, or that they are supported by an apparently very silent "majority" of landowners.)

Immediately after first receiving the Seitz letter and seeing his claim that Mr. Petersen continues as a board member, I confirmed with the Santa Barbara County Elections Office that SRHCSD has no board members, all possible positions having termed out. A copy of the e-mail confirming that fact is also being sent herewith, and we expect SBLAFCO promptly to be informed of this fact.

As far as the Seitz response is concerned, we see it as an open admission that there is simply no legal way for SRHCSD to keep spending taxpayer dollars to further its objectives, all of which are, as they so long have been, completely outside its conditions of formation. Thus, it is an admission that the plan to do so was always illegal, and Mr. Seitz knew that fact.

Of course, if you were consistent with what you have previously told the Commission, you would now tell them that this issue is not even in their purview, as it is only an issue of “expenditures” about which you have repeatedly told this Commission they need not be concerned. However, you no longer have the sole input on these issues, and I suspect you will not try that tactic again.

The issue is, always was, and will continue be one of illegal and improper conduct, directly involving the mis-appropriation of taxpayer money to conduct activities expressly not permitted by SBLAFCO in its conditions of SRHCSD’s formation. My clients are grateful that it has finally become an issue you and Mr. Hood can no longer influence without scrutiny. We intend to keep focused on ending this charade, and putting an end to the illegal use of my clients’ tax dollars for the benefit of a few, private landowners who seek to evade the use restrictions they voluntarily placed on their properties when they either signed the MOA, or took their property subject to that recorded instrument.

Finally, I want you to be clear that, contrary to Mr. Seitz’s claims in his email that my clients and I are only trying to “create problems and not solve them,” with respect to illegal conduct; we acknowledge our efforts to create problems for those who engage in and/or turn a “blind eye” to illegal conduct. As for solving the problems of access into the area within SRHCSD’s boundaries, we have an immediate solution, one we have promoted before SBLAFCO in the past; build the already agreed upon, designed, and ready to implement Memorandum of Agreement access road, according to the terms of the MOA.

No other effort to obtain access to these properties should be approved by any government entity, and no individual owning land within SRHCSD should be heard to speak in favor of any other option, in particular the creation of yet another government entity, unless they first explain why they will not fulfill their legal obligation to build the MOA road.

We repeat our as yet not heeded request to be promptly informed of any non-privileged communications, oral or written, between SBLAFCO and any of its elected or appointed persons regarding SRHCSD, the proposed “Bridge & Highway District,” or Cargasacchi Ranch, if only so that we can learn the information before it is conveniently “forgotten.”
