- 2. The October 4, 2001 minutes were approved, with Commissioner Andrisek abstaining.
- 3. There was no public comment.
- 4. 01-11 Countywide Unincorporated Annexation to the Santa Barbara Coastal Vector Control District

Stacey Matson spoke, representing the County of Santa Barbara.

After due consideration, upon motion by Urbanske, second by Leich, the Commission found the annexation is exempt from CEQA, approved the proposal and directed the staff to complete the proceedings.

- 5. Commissioner Campbell arrived and assumed the Chair.
- 6. 01- 13 Tumbler Annexation to Montecito Sanitary District

Offering to provide testimony if needed were the landowner Joseph Tumbler and his agent Jim Staples.

After due consideration, upon motion by Andrisek, second by Leich, the Commission found the proposal to be categorically exempt, approved the annexation and waived the conducting authority proceedings.

7. Presentation by Carpinteria Water District

Charles Hamilton, General Manager of the Carpinteria Water District, explained the District's plans to construct an enclosed water tank and annex the Rancho Monte Algre property to the District, and answered questions from the Commission. This was an informational presentation and no action was taken.

8. Financial Status Report

The Commission received the project status report as amended by the staff, including a printout of the successful election results.

10. Commissioner and Staff Announcements

Commissioner Campbell noted that he was reappointed by the Board of Supervisors to a new term of office on the Board of Directors of the Cachuma Resource Conservation District.

The Executive Officer announced that:

- At the CALAFCO annual conference Commissioners Campbell and Umenhofer were elected to new terms on the CALAFCO Executive Board and Commissioner Campbell will be the Treasurer of the Association.
- Santa Barbara County was selected to host the 2002 CALAFCO Conference.
- The Commission received the CALAFCO Project of the Year Achievement Award for its processing of the incorporation of the City of Goleta.
- Susana Montana has been appointed as Director of the County's Comprehensive Planning Division, replacing Dan Gira. Commissioner Campbell announced that Ms. Montana will be invited to meet the Commission at a future meeting.
