6. 06-12 Out-of-Agency Service Agreement – City of Santa Barbara (Kimball)

After due consideration, upon motion by Centeno, second by Firestone, the Commission found the proposal to be categorically exempt and authorized the City of Santa Barbara to provide sewer services as recommended.
