Procedures for Conducting Protest Hearings

Dear Members of the Commission:

RECOMMENDATION

It is recommended the Commission authorize the staff to provide standardized protest forms to landowners and registered voters with the notice of protest hearings.

DISCUSSION

This matter was considered by the Commission on March 6 and continued to this meeting for further consideration and possible action.

The staff has conducted protest hearings in recent months for two boundary changes. In both instances we mailed notices of the protest hearing to each registered voter and landowner within the proposal with detailed procedures for submitting valid protests.

Despite what we believed were clear and complete instructions for filing protests, we received a several invalid submittals. Some failed to identify whether the protest was by a registered voter, a landowner or both. We disqualified some protests because they were not dated or did not adequately identify the individual's property.

To improve the process we are recommending the Commission authorize the staff to provide a standardized "protest form." It would be distributed to those who receive the notice of hearing and would also be available on the LAFCO website.

In preparing this report we conferred with other LAFCOs and were informed many use a similar procedure with a standardized protest form.

Valid written protests will be accepted whether or not they are on the standard form – provided they include the required contents – but having this protest form will be a significant improvement in our process and will assist the general public.
