Payroll Services

Dear Members of the Commission:

RECOMMENDATION:

It is recommended that the Commission authorize the Executive Officer to investigate if there is a better payroll service option for LAFCO to use and present these options at a future meeting.

DISCUSSION:

It has come to staff's attention that our current payroll service provider ADP's system cannot adequately complete local State quarterly tax filings as a result of having two CA ID numbers. This has resulted in missed filing for the 2nd, 3rd, & 4th quarter of 2021. ADP has indicated their system does not have the ability to file local State taxes under two separate CA ID's numbers. Two CA ID numbers were required when LAFCO enrolled into State Disability Insurance (SDI) program. Quarterly taxes are required to be filed with the State for all wages and earnings from our payroll payees, which include both Commissioners and staff. Because both the Commissioners and staff are part of the payroll process, quarterly filings of all wages are required for both Federal and State. ADP does make all Federal tax filing on our behalf using our Employer Identification Number (EIN). The Commissioner wages portion pertains to the filing State Unemployement Insurance (SUI) only, while Commission Members are considered exempt from State Disability Insurance (SDI) contribution. Staff (Executive Officer) is not exempt from SDI and we are required to file these contributions with the State.

In addition, staff has had other concerns and issue with ADP services. Many tax filing dating back from 2018 have been rejected, agency representative are not specifically assigned to LAFCO, this requires using the online chat feature or being placed on hold by phone causing a long que for services. Establishing deductions and enrollment into our 457(b) plan presented challenges. However, many of these issues have been resolved. The fact that ADP system cannot properly file our local taxes due to system parameters continues to makes matters difficult and increases time spent, resources, and take efforts away from other responsibilities. Staff would reach out to local accounting firms or CPA service providers for proposals to present to the Commission at a future meeting.

Thank you some clarification regarding these filings. The last report I received from the State indicated their were discrepancies between the Grand Totals and the Sum of individual wages and withholding reported on the DE 9C, see attached notice. Once logged-In to EDD E-Services it shows no employee tax balance is due at this time. It does show ADP LLC as a log-in user and account manager for adp.tax.services.ca@adp.com.

This is the first I have heard that ADP system cannot handle reporting these tax and wages reports. Would it be possible to file these reports if SBLAFCO processed payroll differently under two payroll reports, 1) for the Commissioners (which file the SUI as previous years) CA ID with 6 & 2) one for employee staff (EO) which would include the SDI as the only member that receives this status, CA ID with 7.

Would this allow the ADP system to file the quarterly reports separately under each CA ID?

Since you have multiple CA IDs our system can't file CA.

If we use your ID that starts with 6 CA EDD does not want CA SDI to be filed. If we use your ID that starts with 7 CA EDD does not want CA SIT to be filed. Our system can not handle multiple CA IDs. You will need to file CA yourself.

Please contact your payroll service rep at 877-815-6427 and have them change CA to be set up so you can file each piece under each ID. Otherwise filings are going to reject each quarter.

Dear client

Ca EDD rejected filings for 2Q & 3Q 2021 due to invalid taxes. Since your CA tax ID starts with 7 the agency does not want CA SIT filed. 1Q 2021 did not reject and we had your CA ID that starts with 6. IDs that start with 6 does not want CA SDI to be filed. Our system can not handle multiple CA IDs. If you have multiple IDs you will need to file CA each quarter. If you go back to the ID that starts with 6 you will need to block CA SDI. If you get 1 ID that allows all CA taxes to be paid and filed let me know and I will resubmit the rejected filings. If you file these 2 rejected quarters yourself let me know and I will clear the reject.
