- Consider recommendations regarding LAFCO application file No. 20-02 for an Out-of-Agency Service Agreement for the City of Santa Maria to provide potable water service to Pacific Petroleum located at 1615 East Betteravia Road, Santa Maria, CA 93456 (APN 128-093-013), and consider approval of an Agreement that includes the following actions and determinations:
 - a) CEQA determination. City found the project categorically exempt per Section 15303(d). LAFCO also finds pursuant to CEQA Section 15303(d) and Section 15061(b)(3) of the State Guidelines are applicable;
 - b) The Commission finds the service request to be in the best interests of the affected area. The Commission finds that the new potable water service to be provided responds to an existing threat to the health or safety of the public or residents of the affected territory;

- c) The landowner shall comply with all terms and conditions set forth in the Commission's resolution of approval, including Pacific Petroleum shall execute and record an agreement approved by the Executive Officer that consents to any future annexation of the territory, which agreement shall inure to and bind all successors in interest to the property; and
- d) Said Out-of-Agency Service Agreement is for water service only and shall remain in effect until such time as an annexation is approved by the Commission.
