LAFCO 15-2	Blickley Annexation to the Goleta Sanitary District
PROPONENT:	Property Owners, Madeline and Leo Blickley, by Petition.
<u>ACREAGE &</u> <u>LOCATION</u>	The area proposed to be included in the sphere of influence and annexed to the Goleta Sanitary District is comprised of 10.86 acres including two parcels located at 1310 San Antonio Creek Road and 1200 San Antonio Creek Road. APNs 059-440-012 and 059-440-014 respectively. The property owner are requesting annexation to provide sewer service to these parcels. (Exhibits A and B)
<u>PURPOSE</u> :	The underlying project is a parcel map (14,797) which would increase two existing parcels to three parcels (a net increase of one parcel). The parcel map was reviewed and approved by the County of Santa Barbara Planning Commission and the applicant for the project is seeking to record the parcel map. One of the conditions for recordation is to annex into the Goleta Sanitary District and the annexation requires a sphere of influence change.

GENERAL ANALYSIS:

Description of Project

The underlying project is a parcel map which would add an additional parcel to the two existing parcels. The proposed lot will likely be developed with a single family residence as it is zoned residential.

Project Information

1. Land Use, Planning and Zoning - Present and Future:

APN 059-440-012 would increase in size to 4.175 acres, APN 059-440-014 would decrease in size to 3.179 acres, and the proposed new parcel would be a newly created 3.592 acre lot.

The proposed annexation is consistent with the Comprehensive Plan Land Use Development Policy # 5 which states: "within designated urban areas, new development other than that for agricultural purposes shall be serviced by the appropriate public sewer

and water district or an existing mutual water company, if such service is available." The subject parcels are located within the urban area.

APN's 059-440-012 and 059-440-014 are both within the community plan area for Goleta and are within the Urban Area and South Coast Rural Region.

2. Sphere of Influence:

The proposal area is outside the District's Sphere of Influence, but is contiguous to the District. A Sphere of Influence amendment will be necessary for the annexation to be approved.

3. Environmental Justice:

Annexation will have no effect with respect to the fair treatment of people of all races and income, or the location of public facilities or services.

4. Topography, Natural Features and Drainage Basins:

The property generally lies within a canyon. The topography varies on the parcel with steep slopes generally on the west and north boundaries. A dry creek currently runs along the eastern boundary. There are some relatively flat areas near the creek, particularly on the southern portion of the parcels. The parcels are significantly lower than San Antonio Creek Road.

5. Population:

There are two dwellings unit on the site. There are less than 12 registered voters on the site making it uninhabited.

6. Governmental Services and Controls - Need, Cost, Adequacy and Availability:

The property will receive the same level and range of service as other properties currently served by the district. The initiating agency's "Plan for Providing Services within the Affected Territory," as required by Government Code Section 56653, indicated the ability to adequately serve this site.

7. Impact on Prime Agricultural Land, Open Space and Agriculture:

The project site is not prime agricultural land as defined in Government Code Section 56064, nor is there agricultural production on the site.

8. Assessed Value, Tax Rates and Indebtedness:

The assessed value and tax rate for the property will not be affected by this change. APN 059-440-014 is presently within Tax Rate Area 066159. The assessed value is \$204,202 on the 2013-2014 roll. APN 059-440-012 is also within Tax Rate Area 066159. The assessed value is \$229,884 on the 2013-2014 roll.

The annexing district requests the subject territory, upon annexation, be liable for payment of its share of existing indebtedness to be repaid by user charges, which the staff recommends be included as a condition of approval. The Tax Collector will add to assessments on the regular tax bill levied against the residence.

9. Environmental Impact of the Proposal:

As lead agency, the County of Santa Barbara prepared a Mitigated Negative Declaration (14NGD-00000-00010) dated June 4, 2014 (Exhibit C). The underlying project is a parcel map and lot split. The project presents project-specific impacts that ae potentially significant but can be mitigated to less than significant levels for aesthetics/visual resourced, biological resources, cultural resources, fire protection, geologic processes, and water resources/flooding. The project would not result in impacts related to agricultural resources, air quality, energy, hazardous materials, historic resources, noise, public facilities, recreation, or transportation. There are no adverse cumulative impacts.

10. Landowner and Annexing Agency Consent:

As applicants, the property owners, Madeline and Leo Blickley, has given written consent to the annexation. (Exhibit D)

The Goleta Sanitary District consents to the waiver of conducting authority proceedings provided LAFCO does not record the annexation without prior consent of the District. **(Exhibit E)**

11. Boundaries, Lines of Assessment and Registered Voters:

There are no conflicts with lines of assessment or ownership. The property is contiguous to the District. The site is uninhabited; namely, there are fewer than 12 registered voters.

The boundaries are definite and certain.




