### DISCUSSION

The attached memo from County Elections documenting the results of the June 21, 2017 Protest Hearing held for the Formation of the Los Olivos Community Services District.

There were 80 valid protests filed out of 488 registered voters, or 16.39 percent. Termination of proceedings requires 50 percent of more registered voter protest. Therefore, the protests are insufficient to terminate proceedings.

Interested parties were informed of the results of the protest hearing and the results were posted on the Commission's website.

The formation matter will return to the Commission at the September 7, 2017 meeting. The Ballot Measure, the Impartial Analysis, and requirements for Candidate Statements, will be presented to the Commission at that meeting.
