Following distribution of the agenda packet for this meeting the County Public Works staff has reviewed the types of services the CSAs in Santa Barbara County are actually providing.

As a result we have made changes in our staff report for this meeting. The changes can be seen as <del>cross through</del> and <u>underline</u>.

Our recommendation remains that the Commission adopt the enclosed resolution specifying the types of services each County Service Areas is currently authorized to provide. The resolution has been modified to reflect these changes.

- CSA 3 (Goleta Valley): Street lighting, acquisition and maintenance of parks and open space and special tax support for enhanced library services and support for the Goleta Valley Community Center.
- CSA 4 (North Lompoc): Maintenance of open space.
- CSA 5 (Orcutt): Maintenance of parks and open space.
- CSA 11 (Carpinteria Valley): Street lighting and parks.
- CSA 12 (Mission Canyon): Collection of sewage effluent and inspection of septic tanks.
- CSA 31 (Isla Vista): Street lighting and <u>street tree watering</u> acquisition of open space in conjunction with a redevelopment agency.

- CSA 32 (Entire Unincorporated Area): Extended police protection.
- CSA 41 (Rancho Santa Rita): Maintenance of roadways.
- CSA 45 (Lompoc Library): No library services are provided.

## RESOLUTION OF THE SANTA BARBARA LOCAL AGENCY FORMATION COMMISSION SPECIFYING THE TYPES OF SERVICES EACH COUNTY SERVICE AREA IS CURRENTLY AUTHORIZED TO PROVIDE

WHEREAS, this resolution is enacted pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act (Section 56000 et seq. of the Government Code) and the County Service Area Law (Section 25210 et. Seq. of the Government Code) and

WHEREAS, a County Service Area may provide governmental services and facilities within its boundaries that the County is authorized to perform and that the county does not perform to the same extent on a countywide basis, and

WHEREAS, a "latent power" is any service or facility authorized by the County Service Area Law that LAFCO has determined a County Service Area was not authorized to provide prior to January 1, 2009. (Section 25210.2 (g))

WHEREAS, if the County desires that a County Service Area exercise a currently unused power, the Board of Supervisors shall first receive LAFCO approval and after receiving LAFCO approval, the County Service Area may exercise that latent power, and

WHEREAS, following is a list of County Service Areas and the types of services they are currently authorized to provide:

- CSA 3 (Goleta Valley) District provides street lighting, acquisition and maintenance of parks and open space and enhanced library services.
- CSA 4 (North Lompoc) maintains open space.
- CSA 5 (Orcutt) maintains parks and open space.
- CSA 11 (Carpinteria Valley) provides street lighting and parks.
- CSA 12 (Mission Canyon) collects sewage and inspects septic tanks.
- CSA 31 (Isla Vista) provides street lighting and street tree watering.
- CSA 32 (Unincorporated Area) provides extended police protection for the entire unincorporated area of Santa Barbara Country.
- CSA 41 (Rancho Santa Rita) provides maintenance of roadways.
- CSA 45 (Lompoc Library) is inactive and provides no services.

NOW, THEREFORE, BE IT RESOLVED DETERMINED AND ORDERED by the Local Agency Formation Commission of Santa Barbara County as follows:

- (1) This resolution specifies the types of services each County Service Area is currently authorized to provide.
- (2) A County Service Area can provide other types of services only by first obtaining approval of the Commission pursuant to Government Code Section 56824.10 et al.

This resolution was adopted on February 5, 2009 and is effective on the date signed by the Chair.
