- 1. Chair Cathy Schlottmann called the meeting to order at 2:05 p.m.
- 2. Present were Commissioners Centeno, DeWees, Firestone, Mariscal, Orach, Schlottmann and Wilson, and non-voting alternate Commissioners Fox and Short, Executive Officer Bob Braitman and Legal Counsel Bill Dillon. Commissioners Armendariz and Wolf were absent.
- 3. The Pledge of Allegiance was recited.
- 4. Upon motion by DeWees, second by Firestone, the minutes of the July 3, 2008 meeting were approved as submitted. The motion carried unanimously.
- 5. Public Comment Period There were no comments from the public
- 6. 08-6 Orcutt Fire Reorganization: Dissolution of the Orcutt Fire Protection District/ Annexation to the Santa Barbara County Fire Protection District

After due consideration, upon motion by Centeno, second by Mariscal, the Commission found the proposal to be categorically exempt, approved the reorganization as recommended and directed the staff to proceed.

After due consideration, upon motion by Firestone , second by Centeno, the Commission continued its support of AB 2686 provided the bill contains no provision that would designate an Indian tribe to be a "public agency" for any purpose.

- 12. The Clerk announced the Commission would recess to closed session regarding potential litigation with regard to the Dos Pueblos Golf Links Reorganization.

When the meeting resumed, Legal Counsel reported that upon motion by Firestone, second by Mariscal, by unanimous vote, the Executive Officer should execute and record a certificate of completion for the Dos Pueblos Golf Links Reorganization noting that the 1998 approval did not expire because LAFCO Resolution 98-11 waived the conducting authority proceedings and the Executive Officer should proceed to execute and record a certificate of completion.
