I'm writing to confirm our telephone conversation this morning regarding the staff report for the February 2, 2017 LAFCO meeting on the request by SYCSD to amend its sphere of influence to include Los Olivos, and the pending proposal to form a CSD for Los Olivos. The staff report states: "The sphere of influence amendment request is deemed incomplete pending the MSR/SOI update." In our telephone conversation this morning you advised me that (i) SYCSD's SOI amendment request is "deemed incomplete" only because you need to complete the MSR/SOI update for SYCSD, not because SYCSD has failed to provide any necessary information, and (ii) you do not require any information from SYCSD at this time to move forward with the processing its SOI amendment request. You also advised me that you would clarify with the Commission at the February 2 meeting that SYCSD has provided you with all of the information you have requested up to this point to process its SOI amendment request.
